

## Agreement for subscription to the HGV/LGV Training Network

By making a subscription payment in PayPal via the [www.hgvlgvtraining.co.uk](http://www.hgvlgvtraining.co.uk) website, you are accepting the following terms and conditions:

### 1. Definitions

For the purposes of this agreement, the following definitions will be used:

- (a) "The Website" is the website [www.hgvlgvtraining.co.uk](http://www.hgvlgvtraining.co.uk).
- (b) "The Operators"; Sean W Pargeter and Keith A Pearson – Trading as individual Sole Traders from 162 Lakeside, Woking, Surrey, GU21 8UW and Orchard Lodge, Orchard Way, Aldershot, Hampshire, GU12 4HR respectively.
- (c) "TP"; the individual Training Provider as their legal entity.
- (d) "Subscription" is the inclusion and promotion of the TP Company details on The Website.

### 2. TP requirements for inclusion on The Website

- (a) The TP confirms they have approval from the relevant body to operate as an approved DSA Centre/Instructor, JAUPT Operator or ADR Training Provider for their advertised service listing on The Website.
- (b) The TP confirms they will advise The Operator in writing or email within 3 working days if they are no longer approved by the relevant body for services they offer on The Website.
- (c) Subject to clause 2(a) and 2(b) of this agreement, The Operator does not accept any responsibility for any TP who incurs legal action from any body or individual as a result of mis-representation on The Website.

### 3. Charges

- (a) The TP agrees to pay The Operator one month in advance for their chosen level of subscription which are currently as follows:

Categories (from LGV, Driver CPC & ADR Training)	Cost Per Calender Month (VAT not applicable)
Listing in one category	£35.00
Listing in two categories	£47.00
Listing in three categories	£59.00

Once the TP credit/debit card payment has been processed via PayPal, the TP company details will be listed on the Website within 1 business day (24 hours).

- (b) The TP listing on The Website and subsequent payments will continue until the TP cancels their subscription through their PayPal account. Cancellation of payments can only be instigated by the TP through their PayPal account.
- (c) The TP listing will remain on The Website for a maximum of 14 days from the time the TP cancels their subscription.
- (d) No subscription refunds will be made by The Operator for cancellations by a TP for days subscribed beyond the cancellation date.
- (e) The Operator does not offer refunds under any circumstance other than a situation where The Website is in-operable for more than 3 working days.
- (f) The Operator reserves the right to increase the subscription charges no more than once in any calendar year and only after giving the TP notification 1 calender month in advance. The TP retains the right to cancel their subscription without penalty subject to clauses 2(b), 2(c), 2(d) and 2(e).

### 4. Use of copyright material

- (a) The Operator permits the TP to use the 'Network Member' logo on their website (providing a link to The Website is embedded), stationary, vehicles and other marketing material for the period of their membership.

(b) The TP agrees to immediately cease use and remove all references to The Website from their marketing material and vehicles within 5 working days of cancellation of membership.

## 5. Liabilities

(a) The Operator does not accept any liability for loss of income from the omission of any TP from The Website for any reason.

(b) The Operator does not accept any liability for loss of income from down-time of The Website due to hosting or technical reasons managed by third-party providers.

(c) The Operator does not accept any liability resulting from any legal action taken by a user of The Website against a TP for mis-representation.

## 6. Variation

We may revise this agreement from time-to-time. The revised agreement will apply to the use of our web site from the date of the publication of the revised disclaimer on our website. Please check The Website regularly to ensure you are familiar with the current version.

## 7. Entire agreement

This agreement constitutes the entire agreement between you and us in relation to inclusion of your TP details on The Website, and supersedes all previous agreements in respect of your acceptance of these terms.

## 8. Law and jurisdiction

This agreement will be governed by and construed in accordance with English law, and any disputes relating to this disclaimer will be subject to the [non-]exclusive jurisdiction of the courts of England and Wales.
